The Affiliating Show agrees to ensure:

- a) **The published rules of the NPS are observed and applied in full, including appointment of judges.**
- b) **Judges from the NPS Panel will be used.**
- c) **The wording used in the schedule to describe qualifying classes will be as supplied by the NPS**
- d) **The final schedule will not be printed or issued until the draft has been approved by the NPS and all amendments requested by the NPS have been incorporated.**
- e) **A copy of the final schedule will be forwarded to the NPS.**
- f) **Clear results will be sent to the NPS office within 7 days of the show including the Pony Name and OWNERS name.**
- g) **That all appropriate regulations relating to health and safety requirements, provision of medical services and supplies and fire precautions will be complied with, and that it will be the sole responsibility of the promoting body to ascertain from the appropriate authorities the extent and nature of these obligations.**
- h) **The promoting body will comply with the general duties under the Health and Safety at Work Act 1974 and all other relevant Health & Safety Legislations and ensure the health and safety of all persons, whether they are organisers, participants, members of the public or any other person who may be affected whilst at the event.**
- i) **The Show organisers have Public Liability Insurance for an adequate limit of Indemnity. The NPS has its own cover to protect its liability, but this does not extend to cover shows affiliated to the NPS. The NPS reserves the right to refuse affiliation if shows do not comply with the above terms.**
