All Competitors are assumed to have read these notes and questions arising out of the Show will be determined by reference to these notes.

CLASSES TO BE JUDGED UNDER THE RULES OF THE NPS: Exhibitors are deemed to be conversant with these Rules. For full details please visit www.nationalponysociety.com or contact the NPS Office at rase Centre, Unit 60, 6th Street, Stoneleigh Park, Warwickshire, CV8 2LG. Tel: 01420 88333.

- The OWNER OF THE PONY must be or become a member of NPS Scotland before entering these Finals.
- **EQUINE INFLUENZA** vaccinations are a compulsory requirement for all horses/ponies competing in NPS affiliated classes.
- **ENTRIES AND CLOSING DATES.** Closing date will be Wednesday, 7th August 2024 at 2359hrs for all qualifiers held before this date. This date will be strictly adhered to. No late entries accepted. Entries may only be made online via the NPS Scotland Entrymaster System.
- **EXHIBITOR NUMBERS:** These will be sent to competitors, along with e-admission and lorry passes and other relevant information prior to the show date.
- **PRIZE MONEY:** Prize money is to be collected from the NPS Scotland Secretary's Tent adjacent to the showing rings. Prize money **not** claimed either on the day of the show or within 30 minutes of the awarding of the rosettes in the last class of the day will be forfeited.
- **SCORESHEETS:** Only the WHP score sheets will be available to view by exhibitors. At Finals, NPS Scotland reserves the right to have (use) unofficial mark sheets for the judges' reference only. These marks sheets will NOT be for public display. Please refer to Rule 4.6(k) page 18 2024 Rule Book.
- WHISKERS are not to be trimmed for any breed.
- **IN-HAND STALLIONS AND COLTS:** Handlers of Stallions and Colts in In-Hand Classes must be 14 years old or over before 1st January in the current year. All In-Hand stallions and colts 2 years old or over **must** be adequately bitted and are advised to display a stallion bridle marker.
- RIDDEN STALLIONS: Ridden stallions must display a stallion bridle marker. In M&M classes, riders of stallions must be 12 years old or over when riding small breeds (Shetland, Dartmoor, Exmoor, Welsh A & B). When riding large breeds (Highland, Fell, Dales, Connemara, New Forest Welsh C & D) riders of stallions must be 14 years old or over.
- In <u>ALL</u> classes whips/canes must not exceed an overall length of 75cms (30"). Spurs are **not** allowed in any ridden class. Correctly secured current British standard skull caps/riding hats must be worn at all times when mounted. In the Working Hunter Pony Classes (14-17), riders may only ride one pony in each class.
- **SOLID METAL CURB CHAINS**, frequently covered in leather, are not permitted.
- BITLESS BRIDLES AND RUNNING GAGS ARE NOT PERMITTED.
- THE JUDGES DECISIONS ARE FINAL. A judge may order that a pony that constitutes a danger must leave the ring. An exhibitor may not knowingly exhibit a pony bred, sold, leased, produced, broken or trained by the Judge, and /or his/her immediate family or his/her employer.
- **TIMETABLE: EXHIBITORS ARE ASKED TO NOTE THE TIMETABLE.** Whilst every effort is made, the Organisers cannot be held responsible if classes clash. Judges will not wait or delay classes if a competitor entered in that class is competing in another.
- **CLASSES.** The Committee reserves the right to divide, cancel, or amalgamate any class where deemed necessary.
- **OBJECTIONS** Objections or protests must be made in writing giving full name and address within 30 minutes of the conclusion of the first class concerned and lodged at the Show Secretary's Office, and accompanied by a £100.00 fee, which will only be refunded in the event of the objection being upheld.
- SUBSTITUTION No nomination entries will be accepted and no substitution of animals will be allowed.





- **REFUNDS** no refund of entry fees will be given under any circumstances.
- **HEIGHT:** The Organisers follow the rules of the Joint Measurement Scheme. Exhibitors without a JMS Certificate must be prepared to have ponies measured on the day of the Show.
- **SOUNDNESS** All animals must be sound. If, in the opinion of any Judge, a pony is considered to be unsound, the Exhibitor will be given the option of withdrawing the exhibit from the class. The Judges' decision is final.
- **DISEASE** Any animal found suffering from a contagious or infectious disease is to be removed form the Showground immediately at the request of the Veterinary Surgeon.
- **DOPE TEST** The Committee reserve the right to have any animal tested.
- **CONTROL** Any animal not under control MUST be removed from the Showground immediately when so requested by an Official.
- **DOGS:** Dogs **must** be on a lead and under control at all times whilst on the Showground, in the Stabling, Campsite and parking areas. Owners must clean up after their dogs. Owners whose dogs are found loose or fouling without cleaning up will incur £10 fines which will be donated to the Event Official Charity.
- **LIABILITY:** Save for death or personal injury caused by the negligence of the Organisers or anyone for whom they are in law responsible, neither the Organisers, Blair Castle Estate Ltd, nor any Agent, employee or representative of these bodies accept any liability for any accident, loss, damage, injury, illness to horses, riders, owners, grooms, spectators, land, cars, their contents and accessories, or any person or property whatsoever, whether caused by their negligence, breach of contract or in any way whatsoever.
- **INSURANCES:** All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their animals. They are therefore strongly advised to take out a third- party insurance providing full coverage for participation in equestrian events at home and abroad and to **keep the policy up to date.**
- LOSS OR DAMAGE: The Organisers accepts no responsibility whatsoever for loss, injury or damage, however caused, to any person, animal or property in the Showground, in stables or in car parks.
- NPS SCOTLAND MEMBERSHIP WILL BE SUSPENDED IMMEDIATELY IF:
- (a) Payments to NPS Scotland (entries) or Blair Castle Estate Ltd (stabling) are not honoured by the bank. A surcharge of £10.00 along with any relevant bank charges incurred will be charged if replacements cheques have to be processed; and
- (b) If there is any money owing or if any trophies belonging to NPS Scotland are not returned by the requested date.
- CLOSING OF CLASSES: The class is closed and ponies will NOT be allowed into the ring when:
- (a) In-Hand when the last pony has done its individual trot around the ring before being lined up.
- (b) Ridden (including First Ridden) when the class goes into trot.
- (c) WHP 2 minutes after the last pony has jumped.
- (d) Lead Rein- when the last pony has done its individual trot around the ring before being lined up.

NOTES FOR EXHBITORS FROM BLAIR CASTLE INTERNATIONAL HORSE TRIALS

All competitors are assumed to have read these notes. Any questions arising out of the Show will be determined by reference to these notes.

EQUINE INFLUENZA VACCINATIONS

Following consultation with our veterinary advisors and equestrian governing bodies, Blair Castle Horse Trials has made the decision that **all horses and ponies entering the venue must be vaccinated against equine influenza** according to standard British Horseracing Association guideline, with the last vaccination having been administered no more than 365 days prior to entry to the venue.

• All animals must have completed the primary course of two vaccinations. The last vaccination must





have been administered at least 7 days before entering the venue.

- Horses competing under FEI rules or British Eventing rules must abide by the vaccination rules of that Governing Body.
- Foals under six months of age will be exempt from the vaccination requirement.

Random passport checks will be implemented to verify vaccination status. Any animal identified without a valid vaccination protocol or if the owner/rider is unable to produce a valid passport will result in immediate ejection of that animal from the venue. No refunds will be issued in respect of entries or stabling.

COLLECTING RING/WARM UP ARENA

Ponies must remain in the collecting ring/warm up arena until called forward. The area between the Tay, Garry and Country Fair and Tummel Arenas is to be kept clear at all times. This includes pedestrians, whether they be competitors or general public. No dogs or pushchairs to be allowed into this area.

GENERAL

- 1. **CONTROL OF ANIMALS**: Any competitor/owner who cannot adequately control their animal may be required to immediately leave the showground, on the direction of an Official. No refunds will be issued in respect of entries or stabling.
- 2. **DOGS:** Dogs **must be on a lead and under control at all times** whilst on the Showground, in the Stabling, Campsite and parking areas. Owners must clean up after their dogs. Owners whose dogs are found loose or fouling without cleaning up will incur £10 fines which will be donated to the Event Official Charity.
- 3. **STABLING:** A limited number of stables are available for competitors. Stables will be available from Thursday 22nd August 2024. Due to a limit on the number of stables available this year, competitors will only be able to book a stable for the night before OR the night after they compete. There will be the opportunity when booking a stable to request additional nights. If there is availability, these will be allocated once entries close.

Stabling will be allocated on a first-come, first-served basis. Stable bookings to be made at time of entry.

Bookings close **Tuesday, 30th July 2024**, or when all stables are filled; strictly **no** applications will be accepted after this date. No refunds will be given for stabling cancelled after the closing date.

Please contact the Horse Trials Office if you need to resell your stable. Competitors are **not** permitted to sublet stables or resell stables without prior written permission from the Organisers. This is to ensure we have the correct contact details in case of veterinary emergencies.

Straw is supplied for bedding; competitors requiring shavings are welcome to bring their own or purchase them at the event. Hay and mucking-out tools are not supplied. All stables MUST be vacated and mucked out by 2pm on the day of departure.

4. CAMPING: Only competitors who have booked stables are permitted to stay overnight in their horseboxes. Competitors who have not booked stabling must leave the showground at the end of the show day. Ponies may not be kept in horseboxes overnight. Pens are not permitted overnight or during the day. Anyone erecting pens will be asked to remove them.

Competitors requiring an additional pass for a car and caravan or tent must contact the Horse Trials Office in





advance. Caravans or cars without the correct pass will be redirected to Car Park 1 or the Event campsite, where they will be required to purchase parking or pitch rental, if available. There is no camping permitted in Car Park 1

For those who have booked stabling for the night prior to their competition day, access to the site will be possible from 4pm the day before your competition.

ALL competitors, riders and owners **must** obey the instructions to enter and leave the site and follow directions given for horsebox parking by the stewards and officials in charge of this area.

To comply with the Fire Services' instructions, if you are sleeping in your trailer/lorry, there **must** be a **4-metre gap** in each direction from your trailer/horsebox

Excluding competitors staying in their horsebox, there is **no camping permitted in the lorry parking – this will be enforced.** Please note, there is no electrical hook-up in the lorry parking.

Diesel generators are permitted, providing they are correctly earthed, sited away from flammable materials, and fuel is safely stored. The Organisers may check generators and remove any deemed unsafe. Generators should not be run during Quiet Hours. **Petrol generators are not allowed under any circumstances.**

Campers are requested to respect other guests and keep noise (including generator noise) to a reasonable level – Quiet Hours will be in effect between 11pm and 7am.

5. DISRUPTIVE OR ANTISOCIAL BEHAVIOUR

If in the opinion of the Organisers, any competitor or any member of their group is found to be disruptive or behaving in a way which may be detrimental the event or other competitors, they will be asked to leave the venue. **THIS INCLUDES UNDERAGE DRINKING**. No refunds will be given for stabling or entry fee.

- 6. LIABILITY: Save for death or personal injury caused by the negligence of the Organisers or anyone for whom they are in law responsible, neither the Organisers, Blair Castle Estate Ltd, nor any Agent, employee or representative of these bodies accept any liability for any accident, loss, damage, injury, illness to horses, riders, owners, grooms, spectators, land, cars, their contents and accessories, or any person or property whatsoever, whether caused by their negligence, breach of contract or in any way whatsoever.
- 7. NSURANCES: All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents, or their animals. They are therefore strongly advised to take out a third- party insurance providing full coverage for participation in equestrian events at home and abroad and to keep the policy up to date.
- **8. LOSS OR DAMAGE:** The Organisers accepts no responsibility whatsoever for loss, injury, or damage, however caused, to any person, animal, or property in the Showground, in stables or in car parks.
- **9. CHILDREN:** children under the age of 16 must be supervised by an adult while riding/handling horses or ponies, except for while competing in a class.
- **10. CURFEW:** There is a curfew on riding each evening from 7pm throughout the event. This includes warm-up arenas and hacking as well as competition arenas. Horses and pones may still be exercised in hand or lunged after this time. Anyone found riding after curfew may be asked to leave the venue. No refunds will be given for stabling or entry fee.





ADMISSION

Two passes will be allocated for the first entered pony, with one additional pass for each additional horse or pony thereafter, plus one additional pass for each "Mare with Foal at foot" entry and one additional pass for each rider under the age of 16 years for an accompanying adult. Children 12 years and under do not require a pass. One vehicle pass will be allocated per entry form.

Each additional vehicle or person must purchase the correct tickets through the online box office www.blairhorsetrials.co.uk/box-office. Lorries or trailers that do not contain a horse will not be allowed into the horsebox parking.

LORRY PASSES AND WRISTBANDS WILL BE POSTED TO THE RIDER.
