- Candidates will be evaluated in December 2025, presentation to be made at the 2026 AGM with funding tranches to be paid throughout 2026.
- The successful candidate will be presented with their bursary at the 2026 AGM and will be asked to write a short report for the 2027 NPS Review, explaining what they did with the funds and how it has benefitted them.
