### Schedule Wording

**This class is a qualifier for the NPS/ ANTHONY EVANS ARENA EVENTING CHALLENGE FINAL. The final to be held at Aston Le Walls September 2023, date TBC. The final is open to mares, geldings and stallions four year old and over, in possession of an equine passport but no specific registration or breed society criteria. Ponies' manes may be plaited at competitor discretion.**

**Qualification will be gained by achieving a top 10 placing or a double clear in a qualifying class. Qualification will be confirmed by the NPS Office. Any qualification gained in the 60/ 70cm or 80/ 90cm will jump the higher limit in the final.**

**Riders may only ride one pony in each class at the final. Only ponies owned by NPS members (Life, Qualifying or Performance) can qualify for the final (must be a member at time of qualification).**

**Affiliation Conditions**

**The NPS agrees to provide the following for Affiliated shows:**

- a) Wording for inclusion in the Schedule

**The Affiliating Show's promoting body agrees to ensure:**

- a) The promoting body will complete a risk assessment.
- b) That all appropriate regulations relating to health and safety, provision of medical services and supplies and fire precautions will be observed and that adequate first aid cover will be on site prior to classes commencing.
- c) Return results to the NPS within 7 working days of the end of the show if not available publically on your website.
